1. INTRODUCTION

1.1 Background

In 2015, the Department of State Development commissioned Econsearch to undertake research the small business sector across South Australia. With more than 140,000 businesses in South Australia (98 per cent of the total) employing less than 20 people, the growth and diversity of the State's economy depends on small businesses thriving.

Small businesses are seen as an effective engine for job creation. Government and small business in collaboration with banks and market researchers are identifying local and international opportunities, accessing domestic and international markets and securing capital to accelerate business growth and employment across South Australia. If Government and the small business sector are going to invest in these opportunities, it is important to be able to measure and monitor performance of the sector over time in terms of jobs generated and income created.

1.2 Objectives

The scope of this project with the aim to:

- Estimate a set of economic indicators for the small business sector:
 - employment by business size category by industry
 - turnover by business size category by industry
 - value added (contribution to GSP) by business size category by industry
- Establish a framework for data collection and estimation that will enable ready updates of the small business economic indicators on an annual basis

An outline of the method, data sources and indicators of economic impact used in the analysis are provided in Section 2. Section 3 provides the estimated economic indicators for the small business sector.

Small business employment and household income by industry by region are provided in Appendix 1 and contribution to GSP/GRP by industry by region are provided in Appendix 2.

2. METHOD OF ANALYSIS

2.1 Estimation of Economic Data for the Small Business Sector

2.1.1 Introduction

The ABS releases small business count data under its 8165.0 publication. This publication provides business counts for varying degrees of employment or turnover at given locations and industry activities¹. Currently the business counts by employment, as published in Table 2 (ABS 8165.0), only vary by non-employing businesses, and businesses employing 1-19, 20-199, and 200+ employees. The business counts by turnover, as published in table 3 (ABS 8165.0.3), only vary by businesses with a turnover of \$0 to under \$50k, \$50k to under \$200k, \$200k to under \$2m, and \$2m or more.

However there is a greater need to expand on the data by allowing greater variation to the published employment and turnover levels. Specifically the publication suggests that a significant majority of business would be classified as small business. That is, almost all of the businesses counted seem to belong into the 0 to 19 employees and the 0 to \$2m turnover categories. Considering the significance of these categories it would be advantageous to provide estimates of business counts at a finer detail, e.g. at the per employee basis.

2.1.2 Distribution estimation

Overall Method

The approach involves specifying a probability distribution function (PDF) to estimate the business counts for each increment within the broad bands of employment and turnover business count data. The PDF can be obtained from the corresponding cumulative distribution function (CDF). By fitting an appropriate CDF to the published data it is possible to estimate business counts for specific levels (or increments) of employment/turnover. The CDF values are calculated from the published data, which form the assessment criteria for determining whether a specified CDF is appropriate.

Using 2012-13 end of year business count data², for example, we find the following cumulative proportions for the given levels of employment (Table 2-1).

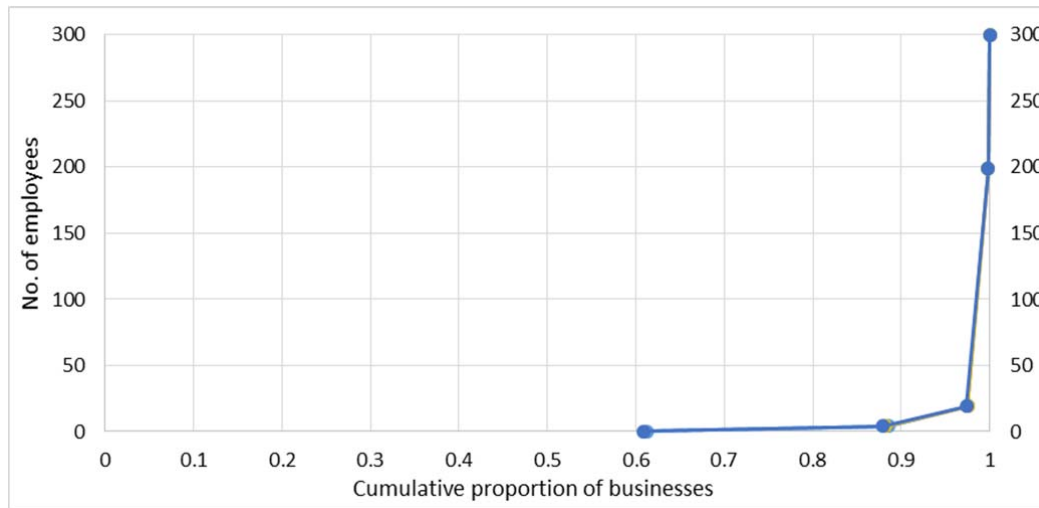

From this we know that about 61 per cent of businesses do not have any employees, 88 per cent employ no more than 4 individuals, 97 percent employ no more than 19 individuals and 99.8 per cent employ no more than 199 individuals. For this scenario, the CDF selected to model the data must align with the above CDF points. In order to smooth out stochastic shocks in the data, a three year average (2011/12 to 2013/14) was applied to the calculated CDF points when forming the CDF selecting criteria. A similar method was applied to the business count data by turnover.

Selecting a function

Initially the appropriate CDF data points were plotted from the published data as this helped suggest an appropriate functional form (Figure 2-1). Although the CDF function should be based on the data points, this would imply a linear relationship for business counts within each employment/turnover band. For example, in the 5-19 band the number of businesses in each increment within the band would have the same average value. This sort of estimation does not appear valid as it is inconsistent with the hypothesis that the number of businesses within an employment/turnover band are concentrated at the lower end of the band. Intuitively, there are likely to be more businesses employing 5 individuals than ones employing 19 individuals.

After testing various CDF functional forms against the calculated CDF points, a generic rational function with an adjustment factor was considered the most appropriate to fit the data. A CDF was constructed by accumulating the values from this generic function which were then converted to percentages of the total accumulation. The specific function was as follows.

$$CDF(n) = \frac{\sum_i^n f(i)}{\sum_i^N f(i)}$$

$$f(n) = \frac{1}{(n+1)^e} - a \frac{1}{\left(\frac{n}{c}+1\right)^{e+1}}$$

where:

- n – is either the number of employees or turnover (\$0,000)³
- N – is the maximum number of employees or turnover (\$0,000)
- c – is a constant term⁴
- e – is an exponential factor parameter
- a – is an arithmetic adjustment factor parameter

Note that when estimating the CDFs, the maximum range for employees and turnover were set to 300 and 10,000 respectively. This was done for practicality reasons and has little effect on the estimated values. That is, given the prescribed data and the functional form, the function $f(n)$ converges to zero as n approaches these maximum values. Furthermore, most

³ Turnover values were set to \$10,000 increments. Note that the published data's CDF points actually spans to under \$50k, under \$200k, etc. The CDF modelling treats these data points as \$50k, 200k, etc. for practicality reasons. interest is in the distribution of small business and not in the distribution of businesses in the 200+ employee and \$2m+ turnover bands.

Selecting Parameters

In order to generate the CDF values, the function $f(n)$ must be estimated for the given parameters e and a for a given set of data. Note that as these parameters change, so will the goodness of fit between the estimated CDF and the calculated CDF data points. The accuracy of fit was determined by taking the total squared differences (TSD) between the appropriate CDF points and values from the estimated function.

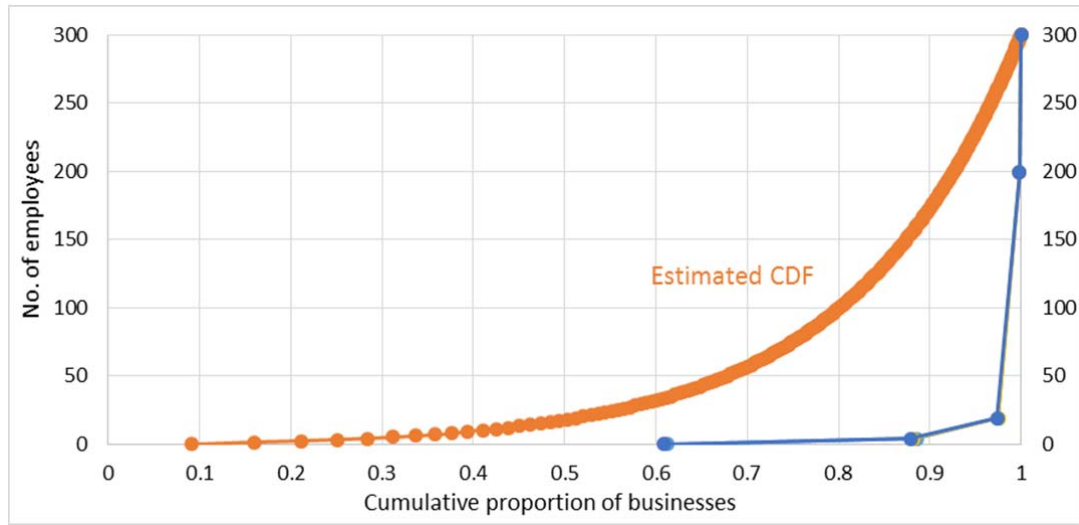
For example, using the end of year business count data for 2010-11, 2011-12 and 2012-13, and setting the exponential parameter and arithmetic parameters to 1 and 0.5 respectively, the fit reported in Table 2-2 was observed.

From Table 2-2 it can be seen that, for the given parameters, this CDF does not fit the data well. The estimated CDF indicates that about 28 per cent of businesses have fewer than 5 employees, while the data shows that the true value to be around 88 per cent, on average. Plotting the estimated CDF against the CDF data points illustrates the goodness of fit (Figure 2-2).

Using the TSD value as the objective function in a minimisation problem, optimal values for the exponential and arithmetic parameters can be found. This operation has been performed using the Excel solver function. Initially, due to multiple local minima arising, solver was run only for the arithmetic parameter over a select range of exponential parameters.

For the given range, the exponential parameter corresponding to the lowest TSD values was observed. An additional range based on this value was used to further narrow down the optimal value of the exponential parameter. This was repeated such that three ranges of exponential parameters were run. Once the best performing parameters were identified a final solver minimisation was run, optimising for both variables, confident that any suboptimal local minima have been avoided.

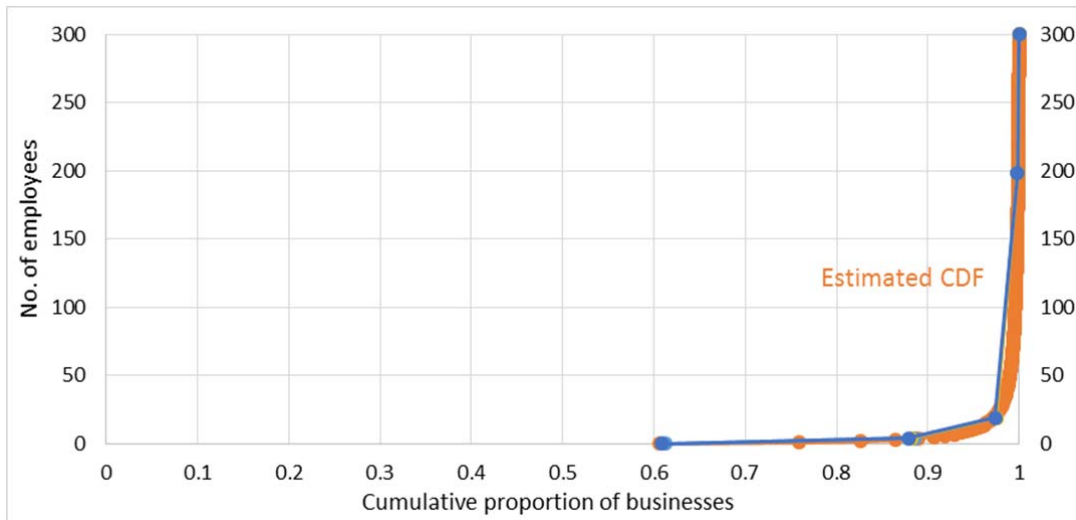
For the current example, exponential and arithmetic parameters of 1.99 and 0, respectively, were observed. Although not perfect, a much better fit can be seen (Table 2-3).

2.1.3 Estimating Values

Once a CDF has been estimated, it is relatively straight forward to estimate the corresponding PDF function. By applying the proportions in the PDF to the total business counts, it is possible to estimate the number of businesses per employee or per \$10k of turnover. However, because the estimated CDF is not a perfect fit, the band sums from the new set of data will generally not correspond exactly with the published data. For example, the sum of estimated business employing 1, 2, 3 and 4 individuals may not match the published count of business employing 1–4 individuals.

To correct for this, the newly estimated series are designated preliminary estimates which must be reconciled to the published counts for the given employee/turnover ranges. For example, the estimates for business employing 1, 2, 3 and 4 individuals are scaled up (down) such that they match the published count of business employing 1–4 individuals. One issue in reconciling the preliminary data in this way is that it may result in some loss of continuity in the data. For example, the shift from 4 to 5 employees may appear to be a slight jump (or drop) in business counts, contrary to the estimated (and smooth) CDF function.

Profiling small businesses - applying the estimated distribution

The method discussed above allows construction of an economic profile specific to small business. The estimated business counts prove useful as we can estimate the portion of small business activity relative to the whole economy.

Specifically, by estimating business counts at a higher degree of employment/turnover variation we are able to produce more robust estimates of small business employment/turnover. For example, if it is estimated that 50 business are employing 10 individuals, then it is straightforward to calculate that a total of 550 jobs are generated from

business of this size⁵. A similar estimate of total turnover for various business sizes (by turnover) can be produced.

Using the estimates of small business employment/turnover we calculate the proportion of business which are considered small entities by either employment or turnover. For our specific purposes we consider small entries to be business employing less than 20 individuals or generating less than \$2 million in turnover. The economic profile is then produced by applying the appropriate small business proportions to the indicators of total employment, full time equivalent employment, household expenditure, household income, gross operating expenditure and taxes less subsidies.

To produce more disaggregated estimates of the business profile, the business counts for each ANZSIC division *i* (19 in total) are estimated. That is we estimate a separate CDF of each industry division, as it is likely that the proportion of small businesses will vary significantly from industry to industry e.g. mining vs retail.

2.2 Economic Indicators

2.2.1 Economic activity

The primary focus in this report is on economic activity associated with the small business sector. The key economic activity indicators considered in this analysis are employment and value added (contribution to gross state product (GSP)).

2.2.2 Employment and gross state product defined

Employment units: Employment numbers are usually reported in either full time equivalent (FTE) units, or job units defined as follows:

- *FTE:* is a way to measure a worker's involvement in a project. An FTE of 1.0 means that the person is equivalent to a full-time worker, while an FTE of 0.5 signals that the worker is only half-time. Typically, different scales are used to calibrate this number, depending on the type of industry and scope of the analysis, but the basic calculation is the total hours worked divided by average annual hours worked in full-time jobs.⁶

⁶ Note that the estimates of total fte employment used in the analysis are derived from the RISE model (EconSearch 2014). There are differences between the RISE model employment values and the ABS labour force survey figures although these discrepancies are not errors but a result of the RISE IO database design. Specifically, the RISE employment figures are based on the hours worked counts from the ABS Census data. Census employment data allow estimation down to the ANZSIC class level at specific geographic locations, which is important for regional modelling purposes. Furthermore, estimates based on census data are preferred as they are derived from the whole population, rather being a sample based estimate. Nevertheless, the labour force survey data are incorporated into the RISE employment estimation process. Specifically, employment growth rates over the period from the census date to the IO database year (by count and by fte – for each ANZSIC division) taken from labour force survey publication are used. Although the census data are scaled up/down by these estimated growth rates, the resulting employment estimates are not necessarily reconciled

- *Jobs*: is used to refer to the number of workers employed, regardless of the number of hours worked.

In this report employment has been reported in terms of FTE units.

Contribution to GSP: is a measure of the contribution of an activity to the state economy. GSP is measured as value of gross output (business revenue) less the cost of goods and services (including imports) used in producing the output. In other words, it can be measured as the sum of:

- *household income* – compensation of employees (wages and salaries) plus payments to owner managers,
- *gross operating surplus (GOS) and gross mixed income (GMI)* – this is calculated net of payments to owner managers
- *taxes less subsidies (TLS)* - taxes less subsidies on products and - taxes less subsidies on production.

Contribution to GSP of an industry represents payments by that industry to the primary inputs of production (labour, capital and land). Using GSP as a measure of economic activity avoids the problem of double counting that may arise from using *gross value of output* for this purpose.

2.3 Input-output Models for SA and Regions

EconSearch has been developing IO models for SA and its regions for various State Government departments and agencies for almost 20 years. The models are provided to Government in a user friendly Excel based package known as the RISE model⁷ which has the standard IO model as its core. The process EconSearch used most recently to update the standard state and regional IO models for 2012/13 (for the Department of Premier and Cabinet) was based on the Industrial Ecology Virtual Laboratory (IE Lab) framework.

This process has been developed under the National eResearch Collaboration Tools and Resources (NeCTAR) initiative, with the University of Sydney (UoS) taking the lead role. This process streamlines database construction, while accommodating construction of Input-Output (IO) tables with a high degree of resolution. The root IO classification encompasses all Statistical Area 2 (SA2) divisions in Australia and the entirety of the IO Product Classification

to the labour force survey values. Furthermore, the labour force survey figures that are used in the analysis may differ from other estimates, as the growth rates' endpoints are based on a four quarter average (i.e. an average over the IO database's financial year) of labour force data.

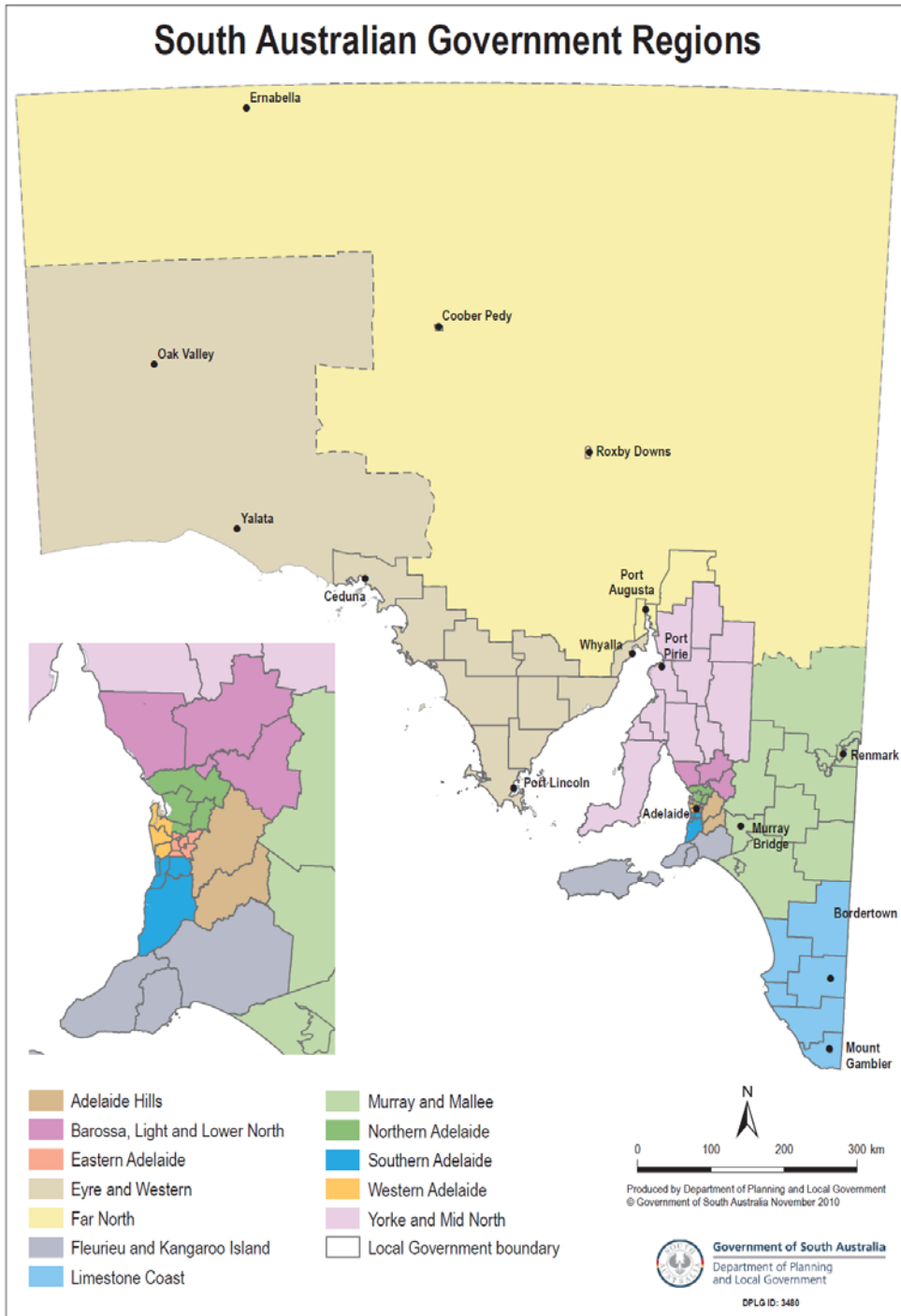

(IOPC)⁸ by the ABS. However due to hardware restrictions some of these classifications require aggregation.

The IE Lab process enables the timely construction and modification of relatively current IO models, as well as construction of tables for previous years. This streamlined model construction process was extremely useful in undertaking the tasks required of this project. The process, outlined in Section 2.1, was used to modify the IO models for South Australia and the 12 State Government regions (Figure 2-4) to enable a consistent specification of the small business sector.

3. SMALL BUSINESS SECTOR ECONOMIC INDICATORS⁹

3.1 Small Business Sector in SA and the Regions

The contribution of the small business sector to the economy of the state and the twelve regions is summarised in Table 3-1. In terms of employment there are estimated to be around 242,000 fte jobs which comprises 34 per cent of the state total. Household income earned by the small business sector is estimated to be almost \$20 billion (36 per cent of the state total) and contributes just under \$34 billion to gross state product representing 36 per cent of total GSP.

The small business share of economic activity does vary considerably across the state. In terms of employment the share ranges from 24 per cent in the Far North, where the economy is dominated by large mining and manufacturing companies, to 43 per cent in the Limestone Coast region where there are a large number of small businesses operating in the agriculture, forestry and fishing, construction, manufacturing and retail sectors.

The household income share earned by the small business sector follows a similar pattern to that for employment, which is consistent with prior expectations. One interesting observation is that in all non-metropolitan regions (except Far North¹⁰) the small business share of the region's total household income is lower than its share of total employment. This suggests that, on average, people working in small businesses in non-metropolitan SA are earning less than others in the workforce. By contrast, in all metropolitan regions the small business share of the region's household income is higher than its share of employment, indicating an average income higher than in the rest of the workforce. This is, at least partly, explained by the differences in small business industry mix, where in the metropolitan regions small business is concentrated in the relatively high paying construction and professional, scientific and technical services sectors, whereas in the non-metropolitan regions small business is generally focussed in the lower paying agriculture, forestry and fishing industries.

Another perspective from which to view the regional data is each region's share of total small business activity in the state. This viewpoint is shown in Table 3-2. The dominance of metropolitan Adelaide in the whole state economy can be observed in the small business sector as well. The four metropolitan regions account for 71 per cent of FTE small business employment, 77 per cent of household income and 72 per cent of the small business contribution to gross state product.

3.2 Small Business Sector by Industry

Small business sector economic activity on an industry-by-industry basis is summarised in Table 3-3. As noted above, small business employment in South Australia was estimated to total around 240,000 in 2012/13. State wide, the construction sector has the greatest share of small business employment, estimated at almost 44,000 (18 per cent of the total). The other major sectors are professional, scientific and technical services (11 per cent), agriculture, forestry and fishing (9 per cent) and retail trade (9 per cent).

Small business was estimated to generate almost \$20 billion in household income in 2012/13. As with employment, household income was most prominent in the construction (\$4.1 billion, 18 per cent) and professional, scientific and technical services (\$3.1 billion and 11 per cent) sectors. However, because agriculture and retail (two of the top four employment sectors) have relatively low rates of pay, they ranked outside the top four household income sectors. Financial and insurance services (\$2.0 billion and 10 per cent) and manufacturing (\$1.3 billion and 7 per cent) sectors were estimated to be, respectively, the third and fourth ranked sectors by household income.

The third indicator reported in Table 3-3 is contribution to gross state product. Because of the high household income and healthy gross operating surplus generated by businesses in the financial and insurance services sector, this sector ranks highest as a contributor to GSP¹¹ (\$5.3 billion and 16 per cent). The other “top four” sectors are construction (\$4.7 billion, 14 per cent), agriculture, forestry and fishing (\$4.0 billion, 12 per cent) and professional scientific and technical services (\$3.3 billion, 10 per cent).

The final column in Table 3-3 shows the small business share of each industry calculated on the basis of fte employment. For some industries small business is the dominant employer, such as rental, hiring and real estate services (87 per cent), financial and insurance services (81 per cent), agriculture, forestry and fishing (79 per cent) and construction (74 per cent). In other sectors it is very small, such as public administration and safety (2 per cent), education and training (5 per cent), mining (8 per cent) and electricity, gas, water and waste services (11 per cent).

Small business employment and household income by industry by region are provided in Appendix 1 and contribution to GSP/GRP by industry by region are provided in Appendix 2. As noted earlier, the small business results reported in this section and Appendices 1 and 2 were estimated using business count data based on employment (small business <20 employees). A set of turnover based estimates for small business (small business <\$2m turnover) appear in Appendices 3 and 4. Employment based estimates for medium business (medium businesses

defined as having between 20 and 199 employees, inclusive) are reported in Appendices 5 and 6. Data limitations prevented estimation of turnover based estimates for medium business.
